BEARDED COLLIE CLUB OF AMERICA TROPHIES

THE BOONE MEMORIAL TROPHY is awarded to the Bearded Collie dog with the highest combined score on sheep, using qualifying scores from A, B, or C course or any combination of these courses. The trophy, offered by Ann Witte in memory of Am/Can CH Artisan Bronze Paladin HXAs, is a small replica of a bronze sculpture of a Bearded Collie facing off a Scottish Blackface ram mounted on a wooden base.

THE ANN ADLER WITTE MEMORIAL TROPHY is presented to the highest scoring veteran bearded collie on any stock/course at each year's National Specialty herding event(s). The trophy, offered by the Great Plains Bearded Collie Club, is a replica of a ram's horn with a Bearded Collie and Scottish thistle engraved in silver on the horn.

THE OWD BOB AWARD is presented to the highest scoring owner-handled Bearded Collie, any level/class/stock at each year's BCCA National Specialty herding trial(s). The trophy, offered by an anonymous group of bearded collie owners, shows a bas-relief sculpture of a handler and a seated bearded collie. Each bears an inscription engraved on a brass plate. A second brass plate provides space for the owner to engrave the name of the dog. A tie would be broken, first in favor of the higher level (any stock, any course) and second, if needed, by the combination of all qualifying scores (any stock, any level, any course) during the specialty trial(s).

Entries must be signed and include the full-page AGREEMENT on the back or attached to the entry form. Incomplete entries are not valid and WILL BE RETURNED.

All entry fees include a \$3.50 AKC recording fee. (Chapter 1, Section 16 of Herding Regulations) . Recording Fees are to be collected by the show-giving club and paid to the American Kennel Club.

The Trial Secretary is not responsible for emails not received. If you have not received a response to an email after 24 hours, please telephone the Trial Secretary 231-633-0112.

The safety of the dogs is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the veterinarian, judge, or Trial Committee.

Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

Entries must be made on Official AKC Entry Forms or copies and must include the signed Agreement and Rules. Junior Handlers must complete the back of the entry form. Please include only AKC titles on your entries.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.

Post Dated and Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

Exhibitors are responsible for cleaning up after their dogs at show site and all hotel, motel, and campgrounds where they are staying while competing in these trials.

Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. The BCCA has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.

All dogs must be on lead or crated at all times except when in the arena.

Dogs must wear a simple well-fitting buckle, snap lock, or slip collar (no tags) or may work without a collar at Trial levels.

Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date other than move - ups. No refunds for duplicate entries.

The Bearded Collie Club of America, their Board, Members, and Sheepsmith Farm and its employees will not be liable for any loss or injury which may be sustained through disappearance, loss, theft, communicable disease, parasites, injury and/or death of dogs entered in this event.

The BCCA does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

EXHIBITOR INFORMATION

TRIAL SITE will be open from 7:00 AM to ½ hour after the events end. Dogs may not be left overnight. Please bring shade cloths, water, tents, and chairs with you. No smoking or vaping allowed on herding venue property.

FOOD SERVICE: Complimentary coffee and light breakfast. Prepaid lunches on site. There will also be a Drover's Dinner held at Block Brewing Co on Saturday night. Sign up for lunches/dinners using the Master Registration Form located at www.bcca2023.com

DOGS ON GROUNDS: **You are responsible for picking up after your dogs and disposing of waste in the proper receptacles.** All dogs present must be held on leash or otherwise restricted except when being judged. Under no circumstances will dogs be allowed to disturb resting stock or interfere outside the arena with another dog's performance in the arena. Un-entered dogs are not allowed in the trial areas.

PLEASE NOTE: Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

ACCOMMODATIONS

Sheepsmith Farm is about 1 hour and 15 minutes with normal traffic to the host hotel in Frankenmuth, so staying close may be a better option. We've blocked a group of rooms at the Comfort Inn, 1645 Commerce Park Dr., Chelsea, MI. Phone: 734-433-8000. This hotel is about 30 minutes (19 miles) south of the herding trials. The alternates list will be used to fill vacancies that occur in the drawn running order, with the first available alternate entry replacing the first vacancy in the class entered. In Test Classes, alternates shall be given priority over dogs eligible to be moved-up.

BITCHES IN SEASON will be permitted to run but will be placed at the end of the running order in Test classes and in catalog order for Trial classes. Please notify the Trial Secretary before the beginning of the class if your bitch is in season.

No dog may be entered in two classes on the same course with the same kind of stock under the same judge at any Test or Trial.
