## **RV PARKING/CAMPING**

The City of Frankenmuth has waived its "no overnight camping" rule for our 2023 Specialty, and will permit a maximum of 20 self-contained RVs (motorhomes and camping trailers only; no tents or pop-ups) to camp onsite in a designated area. This area is conveniently located behind the Kern Pavilion. There will be no electric hookups, but a water source and dump station are available nearby. Camping spaces must be reserved for up to 3 days (Tuesday, October 10 arrival–Friday October 13 departure) at a cost of \$150 for the 3 days. You may opt to stay fewer nights, but you can't stay any longer than 3 nights. NOTE: THE CITY SET THE PRICES; WE DIDN'T.

AKC Rules, Article 1. Sect. 2: In a single show with multiple days of judging, the first day of a show is considered to be the first day on which there is regular conformation judging. #### **Grand Champion Points**

At the judge's discretion, Grand Championship points may be awarded to Best of Breed, Best of Opposite Sex to Best of Breed, and from the Champions of Record remaining in the ring, Select Dog, Select Bitch.

## Awards of Merit

Following selection of BOB, BOW, BOS, Select Dog & Bitch, the judge may, at his discretion, award Judge's Awards of Merit up to 10% of the entries in Best of Breed, including winners of non-regular classes which are eligible for BOB. None are required to be awarded, and no more than the number available may be given. They are not awarded in any particular order; AOM rosettes will not carry placement numbers. Those having received BOB, BOW, BOS, Select Dog & Bitch, Winners Dog & Bitch awards are not eligible for AOMs.

## Reserve Winners Dog and Reserve Winners Bitch Majors

At the national specialty, dogs designated Reserve Winners Dog and Reserve Winners Bitch will be awarded a threepoint major, provided that the number of dogs competing in the regular classes of the Reserve Winner's sex total at least twice the number required for a five-point major in the region in which the event is held. Only those dogs actually competing are counted.



Neutered males and spayed bitches are permitted. Entry fee for Veteran Sweeptakes class is \$30.

## **CLASSIFICATION**

NOTE: Bred-By-Exhibitor (BBE) Class Eligibility (revision 9-02)

- All dogs entered in the Bred-by-Exhibitor Class must be individually registered with the AKC, AS OF THE DATE OF THE EVENT.
- 2. The person handling the dog must be both a breeder of record and an owner of record of the dog.
- 3. To exhibit in this class, family members must be a registered breeder and owner of record.

# NON-REGULAR CLASSES - SINGLE DOG ENTRIES - for Dogs and Bitches

**Veteran Classes --** • Dogs 7-10 years of age

• Dogs 10-12 years of age

• Dogs 12-14 years of age

• Dogs 14+ years of age

NOTE: AKC Rules Applying to Dog Shows. Chapter 11. Sect. 8. Neutered dogs and spayed bitches are allowed to compete in Veterans Classes only at independent specialties and/or those all-breed shows which do not offer any competitive classes beyond Best of Breed. This is an independent specialty.

**Performance Classes -** For dogs and bitches, 6 months of age and over, that have earned at least one title in any AKC Companion or Performance Event (Agility, Herding, Obedience, Rally or Tracking). Dogs entered in these classes must not have been neutered or spayed.

By virtue of winning these Specialty classes, the dog and bitch are eligible to compete for Best of Breed provided they have not been defeated in any other class.

**Sexually Altered Classes -** For dogs and bitches, six months of age or over that have been spayed. The dog and bitch winning these classes are not eliqible to compete for Best of Breed.

## NON-REGULAR CLASSES - MULTIPLE DOG ENTRIES

Stud Dog Class - For Stud Dogs and at least two (2), but not more than four (4) of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog must be entered in the Stud Dog class and shown in the ring with his Get. The Stud Dog may be entered separately in one of the Regular or Non-Regular classes at the regular entry fee with 'Stud Dog' class indicated on the entry form in the space for additional classes at an additional \$25. Or, the Stud Dog may be entered in Stud Dog class ONLY for a \$25 entry fee.

All Get MUST be entered in one of the Regular Classes, but there is no additional entry fee for them as participants with their sire in this non-regular class. The Get only will be judged, on the merits of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or being excused under the Dog Show Rules, AKC policy or the standard for the Breed.

NOTE: AKC Rules Applying to Dog Shows. Chapter 11. Sect. 8. A castrated male may be entered as Stud Dog in the Stud Dog Class and a spayed bitch may be entered as Brood Bitch in the Brood Bitch Class.

Brood Bitch Class - Same as Stud Dog Class except substitute Brood Bitch for Stud Dog, Produce for Get.

Brace Class - A Brace is defined by AKC as two (2) dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in brace competition must have at least one common owner. The dogs comprising the Brace pair must be named at the time of the entry and each MUST BE entered in an additional class. If more than one Brace is entered by the same owner, the dogs comprisimng EACH Brace unit must be designated "Brace #1", Brace #2, etc. Brace entry fee is \$30. per unit or \$12.50 per dog if additional entry. (CONVENIENT FORM TO ATTACH TO ENTRY ON PG.15)

Both dogs competing in Brace must have one common owner.

## **BEST OF BREED COMPETITION**

AWARDS OF MERIT -- Following selection of BOB, BOW, BOS, Select Dog & Bitch, the judge may, at his discretion, award Judge's Awards of Merit up to 10% of the entries in Best of Breed, including winners of non-regular classes which are eligibke for BOB. None are required to be awarded, and no more than the number available may be given. They are not awarded in any particular order; AOM rosettes will not carry placement numbers. Those having received BOB, BOW, BOS, Select Dog & Bitch, Winners Dog & Bitch awards are not eligible for AOMs.

BEST BRED-BY EXHIBITOR - Best Bred-By-Exhibitor will be selected from the winners of the Bred-by-Exhibitor Dog & Bitch Classes following the judging of Best of Breed & Award of Merit Competition.

BEST PUPPY - Best Puppy and BOS Puppy will be selected from the Puppy classes following the judging of Best of Breed & Award of Merit Competition. Only winners of the 6-9 mos. and 9-12 mos. classes are eligible to compete.

NOVICE CLASS -- shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, ina Novice Class. A first place in Novice without competition leading to a Best Junior award with competition-would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

OPEN CLASS -- shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

MASTER CLASS — will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

# 2023 BCCA 4-6 Mo. BEGINNER PUPPY CLASS

The Four-to-Six Month Puppy competition shall be judged in one combined class for dogs & bitches that are four months of age and over but under six months on the day of the event.

Entry and eligibility requirements include:

- AKC registration number or an AKC litter number will be required for all entries.
- A foreign-born dog may enter this class if he/she is registered in the country of origin.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Professional handlers from any country, members of their household and current assistants to professional handlers from any country may not personally exhibit dogs in the Four-to-Six Month competition. Dogs that are owned or co-owned by the aforementioned may compete but must be handled by a non-professional handler.
- Minors (under 18) with amateur status who reside with professional handlers from any country, and current assistants to professional handlers from any country that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may exhibit dogs in the Four-to -Six Month (Beginner Puppy) Competition. Entry fee: \$25.



Entries will be judged based on creativity, photographic or artistic quality and effectiveness in conveying each individual category. A photographer will judge the entries and all contest decisions will be final.


#### **AWARDS**

If a dog is entered in more than one class in the show, fees are to be collected on each entry, except sweepstakes, junior showmanship and multiple dog non-regular classes (American Kennel Club rule, Chapter 11, Section 2.)
- No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.
- Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the event's Show Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry will be made.
- Post-dated Checks and Returned Checks do not constitute a valid entry fee. The Show Secretary will add a collection fee to the amount of each returned check.
